**Regolamenti ta' l-2009 li jemendaw ir-Regolamenti dwar
Prodott għall-Harsien tal-Pjanti (Emenda Nru. 4)**

BIS-SAHHA tas-setgħat mogħtija bl-artikoli 4 u 5 ta' l-Att dwar il-Kontroll tal-Pestiċidi, il-Ministru għar-Riżorsi u Affarijiet Rurali, wara li kkonsulta lill-Prim Ministru u lill-Ministru għall-Politika Soċjali, għamel dawn ir-regolamenti li ġejjin:-

1. (1) It-titolu ta' dawn ir-Regolamenti hu Regolamenti ta' l-2009 li jemendaw ir-Regolamenti dwar Prodotti għall-Harsien tal-Pjanti (Emenda Nru. 4), u għandhom jinqraw u jiftiehm bħala haġa waħda mar-Regolamenti ta' l-2004 dwar Prodotti għall-Harsien tal-Pjanti, hawn iżjed 'il quddiem imsejħin "ir-regolamenti prinċipali".

Titlu u skop.

A.L. 115 ta' l-2004.

**PESTICIDES CONTROL ACT
(CAP. 430)**

**Plant Protection Products (Amendment) (No. 4) Regulations,
2009**

IN exercise of the powers conferred by articles 4 and 5 of the Pesticides Control Act, the Minister for Resources and Rural Affairs, in consultation with the Prime Minister and with the Minister for Social Policy, has made the following regulations :-

1. (1) The title of these regulations is the Plant Protection Products (Amendment) (No. 4) Regulations, 2009 and they shall be read and construed as one with Plant Protection Products Regulations, 2004, hereinafter referred to as “the principal regulations”.

Title and scope.

L.N. 115 of 2004.

(2) The scope of these regulations is to transpose Commission Directive 2008/116/EC of 15 December 2008 amending Council Directive 91/414/EEC to include acetonifent, imidacloprid and metazachlor as active substances, Commission Directive 2008/125/EC of 19 December 2008 amending Council Directive 91/414/EEC to include aluminium phosphide, calcium phosphide, magnesium phosphide, cymoxanil, dodemorph, 2,5-dichlorobenzoic acid methylester, metamitron, sulcotrione, tebuconazole and triadimenol as active substances, Commission Directive 2008/127/EC of 18 December 2008 amending Council Directive 91/414/EEC to include several active substances, Commission Directive 2009/11/EC of 18 February 2009 amending Council Directive 91/414/EEC to include bensulfuron, sodium 5-nitroguaiacolate, sodium o-nitrophenolate, sodium p-nitrophenolate and tebufenpyrad as active substances, Commission Directive 2009/37/EC of 23 April 2009 amending Council Directive 91/414/EEC to include chlormequat, copper compounds, propaquizafop, quizalofop-P, teflubenzuron and zeta-cypermethrin as active substances, Commission Directive 2009/25/EC of 2 April 2009 amending Council Directive 91/414/EEC as regards an extension of the use of the active substance pyraclostrobin, Commission Directive 2009/51/EC of 25 May 2009 amending Council Directive 91/414/EEC as regards the specification of the active substance nicosulfuron, Commission Directive 2009/70/EC of 25 June 2009 amending Council Directive 91/414/EEC to include difenacoum, didecyldimethylammonium

chloride and sulphur as active substances, Commission Directive 2009/77/EC of 1 July 2009 amending Council Directive 91/414/EEC to include chlorsulfuron, cyromazine, dimethachlor, etofenprox, lufenuron, penconazole, tri-allate and triflusulfuron as active substances and Council Directive 2009/82/EC of 13 July 2009 amending Directive 91/414/EEC to include tetraconazole as an active substance.

Amends Schedule IV to the principal regulations.

2. Schedule IV to the principal regulations shall be amended as follows:

(a) Immediately after item 226 “*Verticillium albo-atrum* (formerly *Verticillium dahliae*)” there shall be added the following new items:
