EXPLANATORY NOTE

(This note is not part of the Order.)

This Order amends the *List of Pest Control Product Formulants and Contaminants of Health or Environmental Concern*, to add "crustaceans" and "sesame seeds" to Part 2 of the List and to add "tetrachlorobenzenes" to Part 3 of the List. The Order also reorganizes Parts 1 to 3 of the List, without changing the substance other than the additions previously mentioned.
