Skin : Although there is possibility that it is Out Of Category based on the description that skin sensitization was not acknowledged in the test using the guinea pigs of ACGIH (7th, 2001), it was not clear whether it was the animal test indicated in the technical indicator or not, and we presupposed we could not classify it since we could not negate the sensitizing property clearly.
