## AKTA RACUN 1952

## PERATURAN-PERATURAN RACUN (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 16(4A) dan 35(1) Akta Racun 1952 [*Akta 366*], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Racun (Pindaan) 2025**.

**Pindaan peraturan 26**

2. Peraturan-Peraturan Racun 1952 [*L.N. 440/1952*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan peraturan 26 dengan peraturan yang berikut:

“Poisons  
Wholesale  
Sales Book,  
Poisons Book  
and  
Prescription  
Book.

26. (1) A seller by wholesale of any poison shall keep a register containing information and particulars as required under subsection 15(3) of the Act in accordance with Form A in the First Schedule to these Regulations and such register shall be known as the Poisons Wholesale Sales Book.

(2) A seller or supplier by retail of any poison shall keep a Poisons Book containing information and particulars as required under subsection 23(2) in accordance with Form B in the First Schedule to these Regulations.

(3) A seller or supplier of a poison referred to in subsection 24(1) of the Act shall keep a Prescription Book containing information and particulars required under that subsection in accordance with Form C in the First Schedule to these Regulations.”.

**Peraturan baharu 26A**

3. Peraturan-Peraturan ibu dipinda dengan memasukkan selepas peraturan 26 peraturan yang berikut:

“Records on engagement or employment and daily attendance of registered pharmacist.

26A. (1) A licensed pharmacist shall keep records containing information regarding—

(a) the engagement or employment of every registered pharmacist as required under subsection 16(4A) of the Act in Form D of the First Schedule; and

(b) daily attendance of every registered pharmacist in Form E of the First Schedule.

(2) The information referred to in paragraph (1)(a) shall be—

(a) entered into the record—

(i) immediately before a registered pharmacist commences his duty; and

(ii) not later than a day after the registered pharmacist ceases to be engaged or employed; and

(b) kept and maintained in chronological order according to the date on which a registered pharmacist is engaged or employed.

(3) Any licensed pharmacist who contravenes this regulation commits an offence and shall, on conviction, be liable to a fine not exceeding five thousand ringgit.”.

#### **Peraturan baharu 27A**

4. Peraturan-Peraturan ibu dipinda dengan memasukkan selepas peraturan 27 peraturan yang berikut:

“Preservation  
of document.

27A. (1) A seller, supplier or licensed pharmacist shall keep every register, record or book required to be kept under the Act or these regulations on the premises of the seller, supplier or licensed pharmacist for a period of five years from the date the last entry is made to the register, record or book.

(2) A seller or supplier who receives a written order or a prescription, either in writing or electronic form, in the course of selling or supplying a poison shall keep the written order or prescription on his premises for a period of five years from the date of sale or supply of poison.

(3) Any person who contravenes this regulation commits an offence and shall, on conviction, be liable to a fine not exceeding five thousand ringgit or to imprisonment for a term not exceeding two years or to both.”.

## POISONS ACT 1952

## POISONS (AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by subsections 16(4A) and 35(1) of the Poisons Act 1952 [*Act 366*], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Poisons (Amendment) Regulations 2025**.

**Amendment of regulation 26**

2. The Poisons Regulations 1952 [*L.N. 440/1952*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for regulation 26 the following regulation:

“Poisons  
Wholesale  
Sales Book,  
Poisons Book  
and  
Prescription  
Book.

26. (1) A seller by wholesale of any poison shall keep a register containing information and particulars as required under subsection 15(3) of the Act in accordance with Form A in the First Schedule to these Regulations and such register shall be known as the Poisons Wholesale Sales Book.

(2) A seller or supplier by retail of any poison shall keep a Poisons Book containing information and particulars as required under subsection 23(2) in accordance with Form B in the First Schedule to these Regulations.

(3) A seller or supplier of a poison referred to in subsection 24(1) of the Act shall keep a Prescription Book containing information and particulars required under that subsection in accordance with Form C in the First Schedule to these Regulations.”.



### **New regulation 26A**

3. The principal Regulations are amended by inserting after regulation 26 the following regulation:
