Nama dan permulaan kuat kuasa

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 2) ORDER 2026

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 2) Order 2026**.

(2) This Order comes into operation on 15 January 2026.

Amendment of Third Schedule

2. The Customs (Prohibition of Imports) Order 2023 [P.U. (A) 117/2023] is amended in the Third Schedule, in Part I, in relation to item 50, in column (2), by inserting after subitem (14) and the particulars relating to it in column (3) the following subitems and particulars:
