**Transitional, savings, and related provisions**

## Regulations

### 1 Title

These regulations are the Waste Minimisation (Plastic and Related Products) Regulations 2022.

### 2 Commencement

These regulations come into force on 1 October 2022.

### 3 Interpretation

(1) In these regulations, unless the context otherwise requires,—

**expanded polystyrene** means a lightweight foam that is made by—

- (a) expanding polystyrene using heat and gas or any other means; or
- (b) extruding polystyrene

**home compostable** means home compostable within the meaning of 1 or both of the following standards:

- (a) AS 5810-2010 Biodegradable plastics—Biodegradable plastics suitable for home composting;
- (b) NF T51-800 Plastics—Specifications for plastics suitable for home composting

**plastic** means any plastic material that is manufactured from any source (including a bio-based source), whether or not it is designed to degrade in a particular way

**plastic cutlery**—

- (a) means a product that—
  - (i) contains any plastic; and
  - (ii) is used, or intended for use, as a utensil to eat food; and
- (b) includes forks, spoons, teaspoons, knives, and chopsticks

**plastic drink stirrer** means a product that—

- (a) is a stick that contains any plastic; and
- (b) is intended for stirring a drink

**plastic drinking straw** means a drinking straw that contains any plastic

**plastic or synthetic cotton bud** means a product that is a stem that—

- (a) contains any plastic and has cotton wool wrapped around 1 or both ends;  
or
- (b) has any synthetic fibre similar to cotton wool wrapped around 1 or both ends

**plastic produce bag**—

- (a) means a bag that—
  - (i) contains any plastic; and
  - (ii) is used, or is intended for use, by a person to pack fresh fruit or vegetables and take the fruit or vegetables away from the place at which the fruit and vegetables were packed; but
- (b) does not include a plastic bag that is, or forms an integral part of, the packaging in which goods are sealed before sale

**plastic produce label**—

- (a) means a product that—
  - (i) contains any plastic; and
  - (ii) is used, or intended for use, as a label to be affixed to fruit or vegetables; and
- (b) includes the adhesive of the label

**plastic tableware**—

- (a) means a bowl, plate, platter, or tray that is made wholly or predominantly of plastic; but
- (b) does not include a bowl or plate that forms part of a container with a lid

**plastic with pro-degradants** means plastic that contains additives to accelerate its fragmentation into smaller pieces (for example, oxo-degradable or photodegradable plastic)

**PVC food tray or container** means a product that—

- (a) is a tray or container that contains any polyvinyl chloride or polyvinylidene dichloride; and
- (b) is used, or is intended for use, as rigid and pre-formed packaging for any product that—
  - (i) is, or contains, meat, fish, poultry, or a substitute for any of those, whether fresh, preserved, or frozen; or
  - (ii) is fresh produce; or
  - (iii) is freshly baked where it is sold by retail

**rigid polystyrene** means polystyrene other than expanded polystyrene

**single-use**, for a product, means the product is designed or intended to be used only once or a limited number of times before being disposed of, discarded, or diverted

**specified polystyrene packaging for food or drink** means a product that—

- (a) contains expanded polystyrene or rigid polystyrene; and
- (b) is used, or is intended for use, as a container or packaging for food or drink that—
  - (i) is supplied for immediate consumption (for example, at a restaurant, cafe, or hospital or from a takeaway outlet or office water cooler); or
  - (ii) only in the case of expanded polystyrene, is otherwise sold by retail (for example, at a supermarket or convenience store); but
- (c) is not a rigid polystyrene lid for a drink

**wholesale supplier** means a person that sells plastic drinking straws to persons other than end users.

(2) See section 5 of the Waste Minimisation Act 2008 for definitions of—

- (a) product, which includes packaging;
- (b) sale, which includes—
  - (i) an offer for sale; and
  - (ii) distribution or delivery, whether or not for valuable consideration.

Regulation 3(1) **home compostable**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **plastic cutlery**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **plastic drinking straw**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **plastic produce bag**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **plastic produce label**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **plastic tableware**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(1) **wholesale supplier**: inserted, on 1 July 2023, by regulation 4(1) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

Regulation 3(2)(b): replaced, on 1 July 2023, by regulation 4(2) of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

#### 4 Transitional, savings, and related provisions

The transitional, savings, and related provisions (if any) set out in Schedule 1 have effect according to their terms.

**5 Person must not manufacture or sell certain products (generally containing plastic)**

- (1) A person must not manufacture or sell any of the following products:
- (a) plastic drink stirrers that are single-use;
  - (b) plastic or synthetic cotton buds that are single-use, unless they are used, or intended for use,—
    - (i) as a medical device (as defined by section 3A of the Medicines Act 1981) that is not sold by retail; or
    - (ii) in a veterinary clinic for diagnosis or sampling; or
    - (iii) in a commercial food laboratory for food sampling; or
    - (iv) in a laboratory for scientific investigation (even if they are first used for field sampling); or
    - (v) as part of any kit or other material to test for any medical or scientific matter, including infection or immunity in an individual or animal, and to produce a result without analysis at a laboratory;
  - (c) any product that contains plastic with pro-degradants;
  - (d) PVC food trays or containers;
  - (e) specified polystyrene packaging for food or drink;
  - (f) plastic cutlery that is single-use;
  - (g) plastic produce bags that are single-use;
  - (h) plastic tableware that is single-use.
- (2) To avoid doubt, where subclause (1) applies to any packaging, it applies whether the packaging is by itself or is being used to package another product.

Regulation 5(1)(f): inserted, on 1 July 2023, by regulation 5 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

**6 Person must not sell certain other products that contain plastic**

A person must not sell any of the following products:

- (a) plastic drinking straws that are single-use, unless regulation 7 applies;
- (b) plastic produce labels, unless they are—
  - (i) home compostable; or
  - (ii) used, or intended for use, only on fruit or vegetables that are intended for export.

Regulation 6: inserted, on 1 July 2023, by regulation 6 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

**7 Exemption in relation to sale of single-use plastic drinking straws**

- (1) The purpose of this provision is to enable the sale of single-use plastic drinking straws for use by a person who has a health condition or disability that requires them to use a plastic drinking straw to help them to drink.
- (2) A manufacturer or wholesale supplier may sell single-use plastic drinking straws to any 1 or more of the following entities:
  - (a) an exempt entity:
  - (b) a supermarket:
  - (c) a pharmacy:
  - (d) a wholesale supplier.
- (3) An exempt entity, a supermarket, or a pharmacy—
  - (a) may sell single-use plastic drinking straws to a person who requests them; and
  - (b) must not require a person who requests single-use plastic drinking straws to explain or provide evidence that the person has, or is acting on behalf of a person who has, a health condition or disability that requires them to use a plastic drinking straw to help them to drink.
- (4) A pharmacy may also sell single-use plastic drinking straws to an exempt entity.
- (5) However, an exempt entity, a supermarket, or a pharmacy must not display single-use plastic drinking straws for sale.
- (6) In this regulation, **exempt entity** means—
  - (a) a charitable entity as defined in section 4 of the Charities Act 2005:
  - (b) an education entity as defined in section 10(8) of the Education and Training Act 2020:
  - (c) a hospitality business:
  - (d) a health or disability service as defined in section 5 of the Health and Disability Services (Safety) Act 2001:
  - (e) a public service agency as defined in section 10(a) of the Public Service Act 2020:
  - (f) a Crown agent as defined in section 10 of the Crown Entities Act 2004.

### Part 1 Provisions relating to Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022

Schedule 1 Part 1 heading: replaced, on 1 July 2023, by regulation 7 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

#### 1 Interpretation

In this Part, **Amendment Regulations** means the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022.

Schedule 1 clause 1: inserted, on 1 July 2023, by regulation 7 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

#### 2 Regulations do not apply to plastic produce labels affixed to fruit or vegetables before commencement

Regulation 6(b) (as inserted by regulation 6 of the Amendment Regulations) does not apply to a plastic produce label that is affixed to a fruit or vegetable before the commencement of the Amendment Regulations.

Schedule 1 clause 2: inserted, on 1 July 2023, by regulation 7 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

#### 3 Transition period for the sale of certain plastic drinking straws

(1) This clause applies during the period commencing on 1 July 2023 and ending on 1 January 2026.

(2) Regulation 6(a) (as inserted by regulation 6 of the Amendment Regulations) does not apply to a plastic drinking straw that forms an integral part of the packaging in which goods are sealed before sale.

Schedule 1 clause 3: inserted, on 1 July 2023, by regulation 7 of the Waste Minimisation (Plastic and Related Products) Amendment Regulations 2022 (SL 2022/312).

#### 4 Transition period for sale of certain plastic produce labels

(1) This clause applies during the period commencing on 1 July 2023 and ending at the close of 30 June 2028.

(2) Regulation 6(b) (as inserted by regulation 6 of the Amendment Regulations) does not apply to plastic produce labels that are used, or intended for use, on imported fruit and vegetables.

(3) A plastic produce label must be treated as home compostable for the purposes of regulation 6(b)(i) (as inserted by regulation 6 of the Amendment Regulations) if all of the produce label except its adhesive is home compostable.

## Notes

### **1** *General*

This is a consolidation of the Waste Minimisation (Plastic and Related Products) Regulations 2022 that incorporates the amendments made to the regulations so that it shows the law as at its stated date.

### **2** *Legal status*
