CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Whereas the Minister of the Environment is satisfied that each substance referred to in the annexed Order that is being added to the *Domestic Substances List* ^a under subsection 66(3) of the *Canadian Environmental Protection Act, 1999* ^b meets the requirements set out in subsection 66(1) ^c of that Act;

2 (1) Part 3 of the List is amended by deleting the following:

14068-1 T	Adipic acid, polymer with triethylamine, 3-hydroxy-2-(hydroxymethyl)-2-alkylpropanoate, neopentyl glycol, alkanediamine and 1,1'-methylenebis[4-isocyanatocyclohexane]
14416-7 T	Alkanedioic acid, polymer with alkenedioic acid, carbomonocyclic anhydride and carbopolycyclic diol
14483-2 N-P	1,3,5-Triazine-2,4,6(1 <i>H</i> ,3 <i>H</i> ,5 <i>H</i>)-trione, 1,3,5-tris(3-substitutedmethylphenyl)-, homopolymer, nonylphenol - blocked
14701-4 N	Alkenylanthraquinone
16133-5 N-P	<i>N</i> -Sulfoalkyl-aminocarbonylalkenyl, polymer with <i>N,N</i> -dialkyl-aminocarbonylalkenyl, calcium salt

Alkanedioic acid, polymer with 1,3-bis[(5-isocyanato-1,3,3-trimethylcyclohexyl)methyl]-heteromonocycledione, dialkylpropanedisubstituted and 1,5-pentanedisubstituted

(3) The masked name of the substance “13818-3 N” in Part 3 of the List is replaced by the following:

Carbomonocyclicdisubstituted acid, polymer with alkanediol, hexanedisubstituted acid and heteropolycyclicdione

(4) The masked name of the substance “15105-3 N” in Part 3 of the List is replaced by the following:

Carbomonocyclicdicarboxylic acid, polymer with dimethylalkanediol, 1,2-ethanediol, hexanepolysubstituted acid, heteropolycyclicdione
