AKTA RACUN MAKHLUK PEROSAK 1974

PERINTAH RACUN MAKHLUK PEROSAK (PINDAAN JADUAL PERTAMA) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 58 Akta Racun Makhluk Perosak 1974 [*Akta 149*], Menteri, atas nasihat Lembaga, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Racun Makhluk Perosak (Pindaan Jadual Pertama) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Ogos 2024.

Pindaan Jadual Pertama

2. Akta Racun Makhluk Perosak 1974 dipinda dalam Jadual Pertama—

(a) dengan memasukkan selepas butiran “Ethametsulfuron (termasuk garam dan esternya)” dan butir-butir yang terdapat bersetentangan dengannya butiran dan butir-butir yang berikut:

Nama biasa	Nama kimia
“Ethephon	2-chloroethylphosphonic acid”;

(b) dengan memasukkan selepas butiran “Fenitrothion” dan butir-butir yang terdapat bersetentangan dengannya butiran dan butir-butir yang berikut:

Nama biasa	Nama kimia
“Fenmezoditiaz	(3R)-3-(2-chlorothiazol-5-yl)-8-methyl-7-oxo-6-phenyl-2,3,7,8-tetrahydro[1,3]thiazolo [3,2-a] pyrimidin-4-ium-5-olate”;

- (c) dengan menggantikan perkataan “Laminarine” dengan perkataan “Laminarin”; dan
- (d) dengan memasukkan selepas butiran “Sophamide” dan butir-butir yang terdapat bersetentangan dengannya butiran dan butir-butir yang berikut:

Nama biasa	Nama kimia
“Spidoxamat	11-(4-chloro-2,6-dimethylphenyl)-12-hydroxy-1, 4-dioxa-9-azadispiro-[4.2.4.2]tetradec-11-en-10-one”.

PESTICIDES ACT 1974

PESTICIDES (AMENDMENT OF FIRST SCHEDULE) ORDER 2024

IN exercise of the powers conferred by section 58 of the Pesticides Act 1974 [*Act 149*], the Minister, on the advice of the Board, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Pesticides (Amendment of First Schedule) Order 2024**.

(2) This Order comes into operation on 1 August 2024.

Amendment of First Schedule

2. The Pesticides Act 1974 is amended in the First Schedule—

(a) by inserting after the item “Ethametsulfuron (including its salts and esters)” and the particulars appearing against it the following item and particulars:

Common names	Chemical names
“Ethephon	2-chloroethylphosphonic acid”;

(b) by inserting after the item “Fenitrothion” and the particulars appearing against it the following item and particulars:

Common names	Chemical names
“Fenmezoditiaz	(3R)-3-(2-chlorothiazol-5-yl)-8-methyl-7-oxo-6-phenyl-2,3,7,8-tetrahydro[1,3]thiazolo[3,2-a] pyrimidin-4-ium-5-olate”;

- (c) by substituting for the word “Laminarine” the word “Laminarin”; and
- (d) by inserting after the item “Sophamide” and the particulars appearing against it the following item and particulars:

Common names	Chemical names
“Spidoxamat	11-(4-chloro-2,6-dimethylphenyl)-12-hydroxy-1, 4-dioxa-9-azadispiro-[4.2.4.2]tetradec-11-en-10-one”.
