CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Whereas the Minister of the Environment has been provided with information under paragraph 87(5)(a) of the *Canadian Environmental Protection Act, 1999* ^a in respect of each substance referred to in the annexed Order;

Whereas the period for assessing the information under section 83 of that Act has expired;

And whereas no conditions specified under paragraph 84(1)(a) of that Act in respect of the substances are in effect;

Therefore, the Minister of the Environment makes the annexed *Order 2025-87-04-01 Amending the Domestic Substances List* under subsection 87(5) of the *Canadian Environmental Protection Act, 1999* ^a.

19764-2 N	Fatty acids, C ₁₈ -unsatd., dimers, polymers with acrylic acid and alkanepolyol
19765-3 N-P	Poly(oxy-1,2-ethanediyl), α-hydro-ω-hydroxy-, polymer with alkane, diisocyanato- and alkanol, alkyl-
19766-4 N-P	Heteromonocycle, disubstituted, dihydro-, polymer with α-hydro-ω-hydroxypoly(oxy-1,2-ethanediyl) and α-hydro-ω-hydroxypoly[oxy(methyl-1,2-ethanediyl)]
19767-5 N	Fatty acids, C ₁₈ -unsatd., dimers, polymers with acrylic acid and 1,3,5-tris(2-substituted ethyl)-1,3,5-triazine-2,4,6(1 <i>H</i> ,3 <i>H</i> ,5 <i>H</i>)-trione

19768-6 N-P	Hexanedioic acid, polymer with 2-butene-1,4-diol, 2-(chloromethyl)oxirane polymer with 2-ethyl-2-(hydroxymethyl)-1,3-propanediol, hexanedioic acid, 4,4'-(1-methylethylidene)bis[phenol] and oxirane 2-propenoate, 1,6-hexanediol, substituted-(substitutedmethyl)-trialkylcarbomonocycle, 1,1'-methylenebis[4-isocyanatocyclohexane], 2-methyloxirane and sodium sulfite (1:1)
19769-7 N-P	Fatty acids, alkane, mixed triesters with alkanoic acid and polyalkylene glycol ether with glycerol (3:1)
19770-8 N-P	Fatty acids, alkane, polymers with alkane and alkene fatty acids, polyalkylene glycol ether with glycerol (3:1) and alkanedioic acid
