CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Whereas the Minister of the Environment has been provided with information under paragraph 87(5)(a) of the *Canadian Environmental Protection Act, 1999* ^a in respect of each substance referred to in the annexed Order that is added to the *Domestic Substances List* ^b under subsection 87(5) of that Act;

Whereas the period for assessing the information under section 83 of that Act has expired;

And whereas no conditions specified under paragraph 84(1)(a) of that Act in respect of the substances are in effect;

Therefore, the Minister of the Environment makes the annexed *Order 2025-87-07-01 Amending the Domestic Substances List* under paragraph 87(4.1)(b) ^c and subsection 87(5) of the *Canadian Environmental Protection Act, 1999* ^a.

Amendments

1 Part 1 of the *Domestic Substances List* ^b is amended by adding the following in numerical order:

3 Part 3 of the List is amended by adding the following in numerical order:

19777-5 N-P	Hexanedioic acid, polymer with chlorinated oxirane polymer with 4,4'-(1-methylethylidene) bis[phenol] 2-propenoate, 1,6-hexanediol, 3-hydroxy-2-(hydroxymethyl)-2-methylpropanoic acid and 5-isocyanato-1-(isocyanatomethyl)-1,3,3-trimethylcyclohexane, compd. with <i>N,N</i> -diethylethanamine

19781-9 N-P	2-Propenoic acid, 2-methyl-, telomer with alkyl alkenoate, ethenylbenzene, alkylalkyl 2-substituted acetate, 2-hydroxyethyl 2-methyl-alkenoate and methyl 2-methyl-alkenoate
19782-0 N-P	Polysaccharide, regenerated
