CANADIAN ENVIRONMENTAL PROTECTION ACT, 1999

Whereas the Minister of the Environment has been provided with information under subsections 81(1) to (13) ^a or section 82 ^b of the *Canadian Environmental Protection Act, 1999* ^c, as well as any additional information or test results required under subsection 84(1) of that Act and any other prescribed information, in respect of each substance referred to in the annexed Order;

Whereas the period for assessing the information under section 83 of that Act has expired;

And whereas no conditions specified under paragraph 84(1)(a) of that Act in respect of the substances are in effect;

Therefore, the Minister of the Environment makes the annexed *Order 2025-87-08-01 Amending the Domestic Substances List* under subsection 87(5) of the *Canadian Environmental Protection Act, 1999* ^c.

Order 2025-87-08-01 Amending the Domestic Substances List

Amendment

1 Part 3 of the *Domestic Substances List* ¹ is amended by adding the following in numerical order:

19783-1 N-P	Alkanal, polymers with alkylphenol and alkene oxide
19784-2 N-P	Alkenoic acid, polymer with α -alkeneyl- ω -hydroxypoly(oxy-1,2-ethanediyl)
19785-3 N	2-Propenoic acid, 2-methyl-[phosphinicobis(oxy-ethanediyl)] ester, telomer with methyl 2-methyl-2-propenoate, (phosphonooxy)ethyl methyl propenoate, 2-propenoic acid, sodium (disulfite) (2:1) and sodium 2-methyl-2-[(1-oxo-2-propen-1-yl) amino]-1-propanesulfonate (1:1), sodium salt, peroxydisulfuric acid ([HO)S(O)2]2O2) sodium salt (1:2)-initiated
19789-7 N-P	Alkanedioic acid, polymer with alkanedioic acid, 1,1'-methylenebis[4-isocyanatobenzene] and alkanediol
