Mae'r Rheoliadau hyn yn diwygio deddfwriaeth sy'n cyfeirio at Gyfarwyddeb 2008/98/EC Senedd Ewrop a'r Cyngor dyddiedig 19 Tachwedd 2008 ar wastraff ac yn diddymu Cyfarwyddebau penodol (OJ Rhif L 312, 22.11.2008, t. 3.)

Mae angen y diwygiadau a wneir gan y Rheoliadau hyn er mwyn gweithredu Rheoliad y Cyngor (EU) 2017/997 dyddiedig 8 Mehefin 2017 sy'n diwygio Atodiad III i Gyfarwyddeb 2008/98/EC Senedd Ewrop a'r Cyngor o ran y nodwedd beryglus HP 14 'Ecowenwynig' (OJ Rhif L 150, 14.6.2017, t. 1).

Ystyriwyd Cod Ymarfer Gweinidogion Cymru ar gynnal asesiadau effaith rheoleiddiol mewn perthynas â'r Rheoliadau hyn. O ganlyniad, ystyriwyd nad oedd yn angenrheidiol cynnal asesiad effaith rheoleiddiol o'r costau a'r manteision sy'n debygol o ddeillio o gydymffurfio â'r Rheoliadau hyn.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend legislation which refers to Directive 2008/98/EC of the European Parliament and of the Council of 19 November 2008 on waste and repealing certain Directives (OJ No L 312, 22.11.2008, p. 3).

The amendments made by these Regulations are necessary in order to implement Council Regulation (EU) 2017/997 of 8 June 2017 amending Annex III to Directive 2008/98/EC of the European Parliament and of the Council as regards the hazardous property HP 14 'Ecotoxic' (OJ No L 150, 14.6.2017, p. 1).

The Welsh Ministers' Code of Practice on the carrying out of regulatory impact assessments was considered in relation to these Regulations. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with these Regulations.

Mae Gweinidogion Cymru wedi eu dynodi(1) at ddibenion adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972(2) mewn perthynas ag—

The Welsh Ministers are designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) in relation to—

(a) mesurau ynghylch atal, lleihau a dileu llygredd a achosir gan wastraff a rheoli pecynnu a gwastraff pecynnu(3);

(a) measures relating to the prevention, reduction and elimination of pollution caused by waste and the management of packaging and packaging waste(3);

(b) atal, lleihau a rheoli gwastraff(4).

(b) the prevention, reduction and management of waste(4).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau hyn drwy arfer y pwerau a roddir iddynt gan adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972.

The Welsh Ministers make these Regulations in exercise of the powers conferred upon them by section 2(2) of the European Communities Act 1972.

Diwygio Deddf Diogelu'r Amgylchedd 1990

2. Yn adran 62A(2)(b) o Ddeddf Diogelu'r Amgylchedd 1990(1) (rhestrau o wastraff sy'n arddangos nodweddion peryglus), ar ôl "Directive 2008/98/EC" mewnosoder "as last amended by Council Regulation (EU) 2017/997".

Diwygio Rheoliadau Gwastraff Peryglus (Cymru) 2005

3. Yn lle rheoliad 2(1)(a) o Reoliadau Gwastraff Peryglus (Cymru) 2005(2) (y Gyfarwyddeb Wastraff ac ystyr Gwastraff), rhodder—

“(a) “ystyr “y Gyfarwyddeb Wastraff” (“*the Waste Directive*”) yw Cyfarwyddeb 2008/98/EC Senedd Ewrop a'r Cyngor ar wastraff a diddymu Cyfarwyddebau penodol, fel y'i diwygiwyd ddiwethaf gan Reoliad y Cyngor (EU) 2017/997;”.

Diwygio Rheoliadau Rhwymedigaethau Cyfrifoldeb Cynhyrchwyr (Gwastraff Deunydd Pacio) 2007

4. Yn rheoliad 2(1) o Reoliadau Rhwymedigaethau Cyfrifoldeb Cynhyrchwyr (Gwastraff Deunydd Pacio) 2007(3) (dehongli a hysbysiadau), yn y diffiniad o “the Waste Directive”, ar y diwedd, cyn yr hanner colon, mewnosoder “, as last amended by Council Regulation (EU) 2017/997”.

Title, commencement and application

1.—(1) The title of these Regulations is the Hazardous Waste (Miscellaneous Amendments) (Wales) Regulations 2018.

(2) These Regulations come into force on 5 July 2018.

(3) These Regulations apply in relation to Wales.

Amendment of the Environmental Protection Act 1990

2. In section 62A(2)(b) of the Environmental Protection Act 1990(1) (lists of waste displaying hazardous properties), after “Directive 2008/98/EC”, insert “, as last amended by Council Regulation (EU) 2017/997”.

Amendment of the Hazardous Waste (Wales) Regulations 2005

3. For regulation 2(1)(a) of the Hazardous Waste (Wales) Regulations 2005(2) (the Waste Directive and the meaning of Waste), substitute—

“(a) “the Waste Directive” (“*y Gyfarwyddeb Wastraff*”) means Directive 2008/98/EC of the European Parliament and of the Council on waste and repealing certain Directives, as last amended by Council Regulation (EU) 2017/997;”.

Amendment of the Producer Responsibility Obligations (Packaging Waste) Regulations 2007

4. In regulation 2(1) of the Producer Responsibility Obligations (Packaging Waste) Regulations 2007(3) (interpretation and notices), in the definition of “the Waste Directive”, at the end, before the semi-colon, insert “, as last amended by Council Regulation (EU) 2017/997”.

Amendment of the Environmental Permitting (England and Wales) Regulations 2016

6. In regulation 3 of the Environmental Permitting (England and Wales) Regulations 2016(2) (interpretation: Directives), in the definition of “the Waste Framework Directive”, at the end, before the semi-colon, insert “, as last amended by Council Regulation (EU) 2017/997”.

Revocations

7. The following regulations are revoked—
- (a) regulation 3(2) of the Hazardous Waste (Miscellaneous Amendments) (Wales) Regulations 2015(3);
 - (b) regulation 3(2) of the Waste (Meaning of Recovery) (Miscellaneous Amendments) (Wales) Regulations 2016(4).
