**AGREEMENT that modifies the diverse one by which the quantities or volumes of essential chemical products are determined from which the provisions of the law, published on April 27, 1998, will be applicable .**

The General Health Council, based on articles 4 or. , fourth paragraph and 73, section XVI, base 1a of the Political Constitution of the United Mexican States; 6 of the Federal Law for the Control of Chemical Precursors, Essential Chemicals and Machines for Making Capsules, Tablets and / or Tablets; 4 and 5 of the Regulation of the Federal Law for the Control of Chemical Precursors, Essential Chemicals and Machines to Manufacture Capsules, Tablets and / or Tablets, as well as 1, 9, fraction II and 10, section VIII of the Internal Regulation of the Board of General Health, and

**CONSIDERING**

That the National Development Plan 2013-2018, foresees within its National Goal II. Mexico Including; Objective 2.3. Ensure access to health services, Strategy 2.3.2. Making protective and preventive actions a priority axis for the improvement of health, in which it is considered as one of its lines of action, the one related to reducing the prevalence in the consumption of alcohol, tobacco and illicit drugs;

That the Sectorial Health Program 2013-2018, considers in its Objective 1. To consolidate the actions of protection, health promotion and disease prevention; Strategy 1.4. Promote comprehensive actions for the prevention and control of addictions, the line of action consisting of strengthening actions to reduce the demand, availability and access to tobacco and other psychoactive substances;

That in terms of the provisions of Article 1 of the Federal Law for the Control of Chemical Precursors , Essential Chemicals and Machines to Prepare Capsules, Tablets and / or Tablets, said order is intended to control the production, preparation, disposal, acquisition , import, export, transport, storage and distribution of the said precursors, products and machines, in order to avoid their diversion for the illicit production of narcotics;

Likewise, the aforementioned Law considers in section 4, section II, clauses f) and i) acetic anhydride and potassium permanganate as essential chemical products;

That the General Health Council, in terms of Article 6 of the aforementioned legal system, after a favorable opinion from the agencies, can determine, by means of an agreement published in the Official Gazette of the Federation, the quantities or volumes of essential chemical products from the which will be applicable the provisions of said Law to the persons who carry out the activities regulated by the same, as well as to the third parties with whom they perform them;

That on April 27, 1998 was published in the Official Gazette of the Federation the Agreement by which the quantities or volumes of essential chemical products are determined, from which the provisions of the Law will be applicable, in which they were established , among others, the quantities and volumes corresponding to acetic anhydride and potassium permanganate;

That in the Second Ordinary Session held on November 13, 2018, the Plenary of the General Health Council with the purpose of more effectively enforcing the measures provided for in Article 12, paragraphs 9 and 10 of the Convention of the United Nations Against the Illicit Traffic in Narcotic Drugs with regard to the substances mentioned above, approved to issue the following

**AGREEMENT AMENDING THE DIFFERENT THAT ARE DETERMINED BY THE AMOUNTS OR VOLUMES OF ESSENTIAL CHEMICALS OUT OF WHICH WILL BE APPLICABLE PROVISIONS OF LAW, PUBLISHED IN THE OFFICIAL GAZETTE OF THE FEDERATION ON 27 APRIL 1998**

**UNIQUE ARTICLE.** The table of the Agreement is modified by which the quantities or volumes of essential chemical products are determined from which the provisions of the law will be applicable, published in the Official Gazette of the Federation on April 27, 1998, to remain as follow:
